The Human Resources Administration (HRA) will award contracts to eligible high-quality entities to increase the number of emergency beds and transitional shelter units with a focus

**Tier I Emergency DV Shelter**  
**\$22 million (\$22,763,998) is available to fund 144 beds at a rate of \$93.12 per bed per night for a term of 5 years with one 4-year option to renew. Minimum 10 units.**

**Tier II Transitional DV Shelter**  
**\$93 million (\$93,622,500) is available to fund 400 beds at a rate of \$136 per bed per night for a term of 5 years with one 4-year option to renew. Minimum 40 units.**

The goal of this expansion is to provide emergency shelter and support services so that domestic violence survivors and their families can become stable and safely move into permanent housing. The provider will offer shelter, support services, and care to survivors of domestic violence. Emergency domestic violence shelters provide temporary housing services for a maximum of 180 days in a safe environment. Supportive programs are developed to help clients manage the crisis and
