- **License/State Registration: School-Age Child Care (SACC) registration required by contract date for nonprofit organizations serving youth under age 13.**
- **Anticipated Award Notification: 10/30/2019.**
- **Contract Span: 3 years, to 8/31/2022.**
- **Award Amount: \$1,600 per child.**
- **Initial awards shall not exceed \$800,000 per applicant annually.**

Applicants must offer a broad range of educational, recreational, cultural and age-appropriate activities in a safe environment.
